**SUPERVISED MID-TERM EXAMINATION**

BMSC 230.3 online requires a supervised **mid-term** examination. The BMSC 230.3 midterm is scheduled for Saturday, June 17<sup>th</sup>, 2017 at 9:00 AM. You will be notified through your PAWS email and on the course site of the exact location by the middle of January.

All students will write the midterm in **SASKATOON** unless you reside more than 110KM from Saskatoon. **For those students that are more than 110 KM from Saskatoon you will need to complete the Special Centre Form and follow the procedures of establishing an invigilator found below.**

**Special Centre Examination Arrangement Procedures**

I. The Invigilator:

It is the student's responsibility to forward the name of a reputable individual who is willing to supervise this examination. The student must make all necessary arrangements with this individual to write and submit the examination. This includes any financial reimbursement that might be required.

The Invigilator **must** be an established member of the community, whenever possible a representative from a university, college, or school in either an administrative or academic capacity, or otherwise employed in a professional or managerial occupation (e.g., clergy, law enforcement officers). **Other University of Saskatchewan students, relatives, friends, neighbours, co-workers, acquaintances or persons residing at the same address cannot invigilate exams.**

II. Examination Procedure:

- 1) The mid-term examination will be mailed to the Invigilator at least 10 days prior to the day it is to be submitted. The mid-term examination for BMSC 230.3 **is scheduled to be written on Saturday, June 17<sup>th</sup> (9:00 AM).**
- 2) The student must contact the Invigilator during the week prior to the examination date and confirm final arrangements to write the examination.
- 3) Upon completion of the examination the Invigilator will seal it in the envelope provided and return it to the Independent Studies Office.
- 4) The student is responsible for all costs incurred in the writing of this examination. **Please note that there is no charge for students writing on campus.**
- 5) The University of Saskatchewan reserves the right to reject prospective invigilators.
